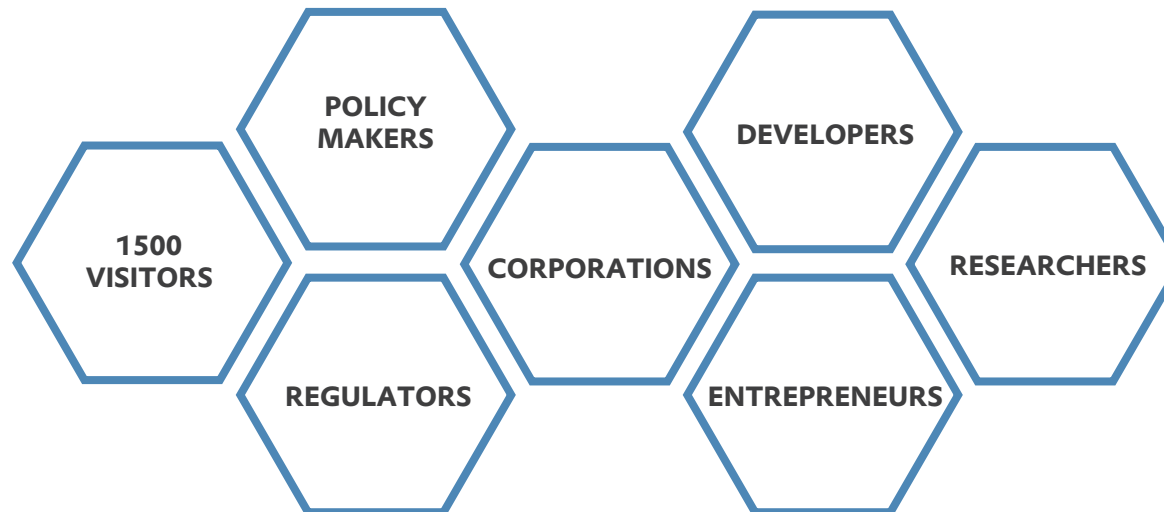

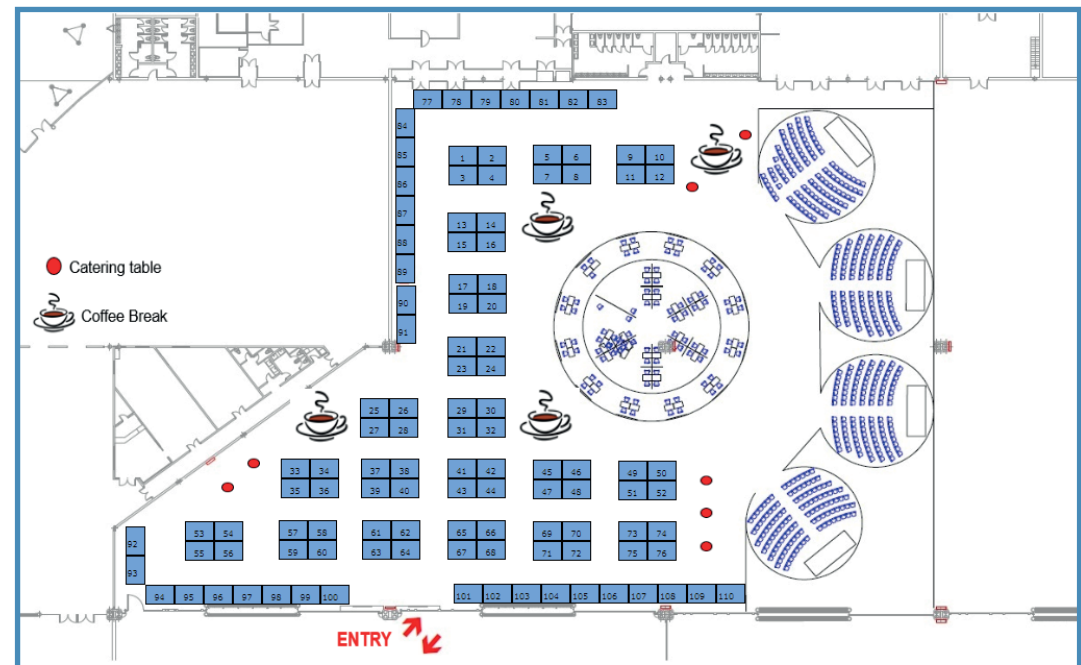
EXHIBITION

Entrepreneurs and leaders engaged in the blockchain space will be able to foster collaboration and networking through their booth presence. Booths will be organized to run concurrently, leveraging the global nature and reach of the event with stakeholders and high-level participants from several regions.

The booths distribution and characteristics will be as follows:

- ▶ Booth of 3m X 2m.
- ▶ The available space for the commercial exhibition is divided in 110 6m² (3x2) modules, and will be located in the "Pabellón 2"
- ▶ Every booth will be located in the same floor. In addition, coffee breaks and work lunch will be served in the exhibition area.
- ▶ Modular structure, carpet, illumination and power are included in the booth price. Maximum height for modular booths is 3 meters. Maximum height for design booths to be determined.

**Provisional exhibition layout (subject to change due to organizational needs and/or unsold booths). It is the exhibitor's responsibility to check with the Technical Secretariat the final layout of the exhibition, and the height of the side booths.

ONLINE APPLICATION

From Thursday, September 9th, 2019 at 10:00h a form will be enabled in the “Sponsors” section of the congress website (<https://www.blockchainconvergence.com/>) so that companies can make the reservation of the booth and other sponsorships online. The booth online reservation form and other sponsorships will show you the current availability of all services so that the allocation of spaces and other services is in strict order of request.

During the reservation process you can select the location of your booth and at the end of the process you will automatically receive an e-mail with the detailed summary of your request along with an invoice of the total amount that must be paid before the payment deadline.

The Organizing Committee reserves the right to alter time schedules, differing, reducing or extending the period of celebration of the exhibition, or eventually to change the venue, for reasons beyond the organizer's control or for major contingencies.

These circumstances would justify neither a partial, nor a total cancellation of the commitments of Exhibitors, nor damage compensation.

CANCELATION OF PARTICIPATION OR "FORCE MAJEURE"

All cancellations must be sent in written to the Technical Secretariat. Deposits will not be refunded.

If for any reason or circumstance of major force beyond our control, the congress could not be celebrated, exhibitors and sponsors commit not to claim against the organizers, being refunded the sums paid as deposit, less an amount for general expenses spent at the moment of the cancellation of the congress.

LIABILITY AND INSURANCE

Companies participating in the Congress are required to take out appropriate insurance. The Congress Organizer cannot accept liability for personal accidents loss of or damage of private property of participants, either during or indirectly arising from the Convergence- Global Blockchain Congress. Participants are advised to issue their own personal travel and health insurance for their trip.
